Clerk to contact Jaycees and invite them to talk with Chief Gates about the ferry off-loading traffic.

Communications specifications from General Electric were examined. Chief Leak asked the Council to publish bid notice. Bourne made the motion to call for bids for a new system, seconded by DuBois and unanimously approved.

Shorelines permit #4 was tabled until plans are complete; a plan of the building addition is needed.

The condition of the Town's water supply was discussed and it was decided to ask Amos Coffelt, Engineer, if he could assist the Town in relieving the problem and also the problem of odor from the sewer treatment plant. Foreman will discuss with Mr. Coffelt and possibility of Mr. Coffelt being able to certify a member of the town crew for both water and sewer departments.

Foreman discussed the need of a new storm sewer from the drug store up Second Street to Reed Street. Council advised Clerk to call for bids for necessary materials.

Corner of First and Spring Streets has a problem with water draining into Sunshine Alley and town crew should work towards eliminating the problem. Paving on Spring Street was discussed. Samples were taken but no results as yet.

Resolution #283, a resolution accepting the bid of Assoc. Sand and Gravel for storm sewer pipe and related objects read. Motion was made by DuBois, seconded by Bourne to pass Resolution #283, and unanimously approved.

Resolution #284, a resolution accepting the bid of General Electric for communications was read. Motion was made by DuBois, seconded by Bourne to pass resolution #284 and unanimously approved.

Resolution #285, a resolution accepting the bid of Pierce Manufacturing Co. for a new fire truck was read. Motion was made by Erickson, seconded by DuBois to pass resolution #285 and unanimously approved.

Tom Perkins appeared before the council and advised he would have a drawing for the Council's inspection for the next meeting of his six-plex. Council advised it was not necessary; Foreman Burton could advise him on the best way to install water to the units,

Mr. Ralph Reed appeared as head of a Citizens committee and asked Attorney Schmidt to speak for him. Attorney Schmidt presented a proposed ordinance re-drafting Ord. #112 to bring it up to date as to restoration and preservation of old buildings that may be of historical or architectural interest; and to include further commercial development within the Town of Friday Harbor. Also improve on fire clause. Nothing in the new ordinance to fear since the ordinance protects and enhances the proposed re-setting of the old buildings. He asked council to consider the proposal.

Ed Nash asked if Council objected to his moving the building onto his lot next to Marbles Promart and explained what he could do with the available ground space. General discussion followed and it was announced the Council and other interested parties would meet at 10:00 a.m. Friday at the building site and then continue the council meeting at 2:00 p.m. Friday the 6th of April.

Miss Henry, Mr. Whitmill, Brown and Black appeared as invited. Mr. Black gave a talk on solid waste disposal and necessity of preparing a solid waste plan and suggested county and town work jointly on the plan. Einar Neilson presented plan and resume of possibilities of using existing dump for another 20 years. Estimate of \$2500 for initial cleanup expense; \$1500 for new roadway and 1000 cu. Yards of dirt for fill. Mr. Black felt this would be fine for an interim



plan. When Mr. Black's planning is completed there may be federal and state money available for future use. Council feels the Town has furnished the island inhabitants a dump for at least 2~ years and would now like the County to take over for the next 2~ years. Mr. Whitmill stated the Commissioners are hoping to do the study at no cost to the Town, but would like to join in later on a permanent plan for the future. Council asked if County was prepared to join in cost of re-habilitation the present dump but Commissioner felt it was preferable to study further before committing money. Mr. Black is planning on meeting with the public within 2 weeks, final meeting in May and the preliminary plan in June and final in July. Mayor asked commissioners to have County Prosecutor draw up a letter of agreement. Mr. Black will try to set up a meeting with general public and council next week. Mr. Whitmill expressed appreciation for being invited to the meeting and hopes for a long period of cooperation with the Town.

Mr. Rouleau and Mr. Walrod appeared with a request for a permit to install two 2000 gallon gasoline tanks underground. DuBois made the motion to grant the permit, seconded by Nash and unanimously approved.

Foreman Burton reported the lake level was 23" last Friday; the highest point being this winter.

Grace Nichols' problem of sewer back-up discussed. One manhole to be put in. Clerk to invite Mr, Al Nash to attend next council meeting to discuss tree roots in sewer line.

Foreman Burton presented council with County's estimate of re-doing several streets. Estimate in excess of \$29,000 plus cost of ballast. Work to begin April 23rd.

Census reported by Councilman Getz: 886 total people; 335 houses; 30 vacant houses; 27 apartments; 4 duplex units; 1 four plex; 2 hotels; 2 motels; 1 convalescent home; 1 trailer court. Final report will be ready for next meeting. This is a Preliminary census.

Adjourned at 10:15 pm to continue at 2:00 p.m. Friday, April 6.

The ordinance that Charlie Schmidt presented to the council on April 5, 1973 was discussed. It was decided to have another one written.

Motion was made by Erickson, seconded by Bourne to approve Weeds request for water for a single-family residence, and unanimously approved.

Shoreline Management Permit for Mr. Holm was discussed and tabled until the next meeting.

The 1973 Census taken by Lawrence Getz and Ross Ertter was presented to the Council: Population 889, Housing Units 411, Vacant Houses 35, Vacant Apartments Units 5, Trailers 16, Streets 43. Motion was made by DuBois, seconded by Erickson to accept the census.

Mr. Ertter asked the council if they could incorporate the street light in front of his property on Marguerite, into the town. Clerk is to get in touch with George Goff to see how many other private street lights are located on the street, and find out how much more it would cost us to add Mr. Ertter's light to the town.

Mr. Anderson was here to see if the council would approve his water request in Harbor View Place. Councilman Erickson has been in contact with Carey and Kramer to see if it would be advisable to let Mr. Anderson hook up to the towns water. Councilman Erickson and Clerk will write a letter to Carey and Kramer.

Mr. Phifer was here to let the council know that he was putting in a diesel motor generator. The tank for the fuel would be buried under ground. It would meet the same requirements that are needed in Seattle. The council advised Mr. Phifer that he would need a permit to do this. Council OK'ed Mr. Phifer's plan.

Foreman Burton informed the council that Sam Buck wants to relocate his sewer from the front of his building to the back. He would like to get a relocation permit. Council advised that there is no such permit. He would have to get the regular sewer hookup permit and sewer installation.

Council told Foreman Burton that he has done a very good job on the City Park.

The quarterly report on the expenditures and balance of the budget was given to the council.

Councilman Bourne presented a sketch from the Lions Club for the park on Front Street. A general discussion followed. At present the council asked Foreman

Burton to put up the fence, on recommendation of the Chief of Police, until something else is done.

Mr, Al Nash was present at the council meeting on the invitation of the council. The council advised Mr. Nash that his tree roots had gotten into the sewer across the street. Foreman Burton is going to put some Sewer Compound into that part of the sewer to see if he can stop the roots from growing into the sewer line.

Al Nash said that the sidewalk in front of Queen City Savings is in need of repair. Clerk is to write to Queen City Savings and advise them it is their responsibility to keep the sidewalk in good condition. Al Nash also was concerned about the dynamite blasting in the town. He suggested that a warning be given to all people in the vicinity of the blast and that a net or something be put over the area of the blast so to catch the rock and debris. Chief Gates is to talk to Warren Russell on writing up an ordinance against or on the safeguards of dynamiting in the Town limits.

Material on professional planning was tabled to next meeting.

Treasurer Vandersluys told the Council we needed a new ordinance for mobile homes. Clerk to write to our attorney and ask him to write up an ordinance.

Chief Gates advised council that we will need an ordinance for the 19 year olds to drink by June 6, 1973. Council advised Chief Gates to get together with Warren Russell.

Chief Gates also advised council we will need some signs and an amendment to Ordinance #9 for not sleeping in the city park or any park in town.

Ordinance #393, an ordinance regulating the storage and use of explosives in the Town of Friday Harbor was read. Motion was made by Getz, seconded by Bourne to accept Ord. #393, and unanimously approved.

Dick Warren from Kramer, Chin & Mayo discussed problem of water to Park Street and adjacent areas and advised council that a larger pump is needed to push the water up the hill; a six-inch main is needed now. They gave an estimate for the pump and line at tank of \$7000. They advised Chas. Schmidt should connect at Park St. with a 6" line, following page 3 of Rules and Regulations; and should pay \$3.75 per front foot as well as a meter charge. An L.I.D. outside town limits can be formed for Harbor View Place. Neil Carter would have to get permission from other owners on Harbor View Place to hook up to their line. Town is under no obligation to run line for anyone. Discussion on cost to operate booster pump and suggested people pay an additional amount to help cover cost of operation. Council asked Mr. Warren to draw up the plan for a new pumping system. Letter from Mr. Livingstone, State Health Dept., was reviewed by Mr. Warren and advises Council not to apply for license for supplying water to boats since Coast Guard would draw a lot of water quickly at one time. Feels water system is sufficient and meets all State requirements and will advise Mr. Livingstone of this. State Ferries sewage drop discussed. Ferry system to install large enough storage tank and must expect to pay substantial fees. It may be necessary to install a secondary treatment plant in about 2 years. University of Washington is going to wait another year or so before hooking up to sewer system. All water systems in the State have to file a plan and financial statement in July, which will cost from \$1200 to \$1500 to do. Storm sewer discussed. Culvert needed at the corner near the city park property and should be done right away. Should be no trouble to get an easement from Dogan to cross his property. Re-stated should decide about making the plan for the State.

Mr. Black and Mr. Rose appeared before the Council and Mr. Rose spoke on ways and means of solid waste disposal by joining Skagit and Island counties, with possibly funds available from Federal and State. Left pamphlets with council on Facts about Resource Conservation and Development Projects. Local people must get it started, the Grange and service clubs. Question: Could swimming pool be included? Answer: Yes, also community hall and other needed items. This would need to be a long-range project. Question: Do we have to spend a lot on planning? Answer: No, people do the planning with Soil Conservation Office. Mr. M. Carter stated there are a lot of trained, experienced retired people who would help with the planning at no fee.

Mrs. Schuman stated 4H and Grange members would like to clean up the end of West Street put up a picnic table or two with benches for picnics and view watching. New logs are needed. Mrs. Frank Wilson and 4Her's will mow the lawn and weed, and Grange will supply a garbage can. Also, would like permission for the 4Her's to put the 4H emblem back on the garbage cans around town. Permission granted. Foreman Burton agreed to get the new logs and bring in some dirt for a lawn. Mr. Lou St. John, County Planning Director, introduced himself and offered services. Mrs. Rist resignation accepted. Mayor Browne gave Oath of Office of Town Clerk to Eleanor Novak.

Water hook-up for Jepsen & Jackson discussed. Moved by Erickson, seconded by Bourne to permit the hook-up and approved.

County was to advise Town by first week in May on solid waste disposal. No word as yet so Clerk to write letter to County.

2 hour parking on Spring Street discussed. Mayor asked Councilman Nash to investigate feelings of the merchants on this; also to discuss with Marshal and State Patrolman. Street stripes need replacing and will be done soon per Foreman Burton.

Council met in regular session with Mayor Browne presiding.  
 Councilmen present: Erickson, Dubois, Getz, Bourne, and Nash.

Minutes of previous meeting were approved as read.

Correspondence:

U.S. Dept. of Interior (BPA): letters of agreement between BPA and the Town.  
Warren Russell: request for water hook-up for Maude Lohr.

Motion was made by DuBois, seconded by Nash to approve Maude Lohr's request for water hook-up on the Friday Harbor Sand & Gravel water line, for a single family residence. It was unanimously approved.

A public hearing was held on LID #39, Harbor View water line. Dan McDonald of KCM explained the steps to be taken to initiate and complete and LID. There were several complaints that were explained by Mr. McDonald. One of which is the fact that possibly the dogleg in the line could be straightened and the line thereby be shortened. Another question was weather or not the people living out side the Town but close to the line would get a hook-up without paying a share of the LID, but it was explained that any new hook-ups to the line would have to pay proportional share of the total expense. Motion was made by DuBois, seconded by Bourne to proceed with the engineering of the water line.

A public hearing was held on the Franchise for a cable TV, Mr. Ledman brought up several questions on the Franchise Ordinance, and parts of the ordinance were rewritten to reflect his thoughts. Mr. Hirshfield advised the Council that the Federal Communications Commission should approve the ordinance. Motion was made by Erickson, seconded by Nash to adopt Ordinance #399, an Ordinance creating and awarding a cable television franchise in the Town of Friday Harbor, and Rules Governing the operation of same.

Mr. James Capron proposed the annexing of some property to the Town of Friday Harbor and was advised by Town Council that he would have to submit an application and go through the proper channels.

A public hearing was held on the preliminary 19714 budget. Budget was read by the Treasurer, Cleave Vandersluys and discussed.

Mayor Browne instructed the Clerk to send a copy of the Fire Dept. budget to the County's Committee for Fire District #3.

Motion was made by Nash, seconded by Bourne to pass Ordinance #398. An Ordinance for the Town of Friday Harbor for a Supplemental Budget of certain sums for the year 1973.

There being no further business the Council adjourned at 10:30 P.M.

Motion was made by Bourne, seconded by DuBois to pay bills and unanimously approved.  
Correspondence:  
San Juan County Commissioners: Refuse agreement between Town and County.

The committee representing San Juan County Fire District #3 were present to discuss the Fire Departments 1974 Budget, in regards to the fire protection to the County. After much discussion the committee adjourned to the Clerk's office for a meeting with Councilmen Bourne. It was deked that Attorney Redman would present to the County a request for \$9326.00 for fire protection for Fire District #3. It was also agreed that in the future representatives from the Town of Friday Harbor or Fire Dept. would have quarterly meetings with representatives of Fire District #3 to discuss the future fire protection and charges between the two bodies.

Motion was made by Nash, seconded by Erickson to call for bids for a tractor with loader and backhoe. Such bids will be opened Jan. 3, 1974.

Councilman DuBois was advised by Attorney Schmidt that a Shoreline Management Permit would not be required for a alterations and repairs on the out side for less than \$1500.00 for the Old Moose Hall on Front & Spring Street. Attorney Linde was instructed by the Mayor to look up the statute on Shoreline Management Permits for alterations inside of the buildings.

San Juan County Sheriff Don Brown was present to present a proposal that the County contract the Town's law enforcement during the year 1974 for \$12,944. After discussing the proposal with members of the public present, it was obvious that they were very satisfied with our present Marshal system. The present Marshalling system although it is slightly more expensive gave the Town much more coverage for more hours per day.

Mayor Browne checked with Attorney Schmidt on the County's reply to the Town's charges for the use of our Refuse Disposal Site for the 3rd quarter.

The parking lot behind the Town Hall, which the Town leased from Thomas Blunden, was discussed. It was suggested that as the parking lot is being used very little at this time and that it might get more use if the Chamber of Commerce leased the lot themselves.

A notice of intention to petition for annexation was presented by Mr. James Capron or property laying adjacent to the easterly boundary of the Town of Friday Harbor and northeasterly of Warbass Way, approximately 250 feet on the

water front. A motion was made by DuBois, seconded by Bourne to accept the petition to annex, unanimously approved.

197h Budget was discussed by the Council. Because of the late hour the meeting warn closed at 10:15 P.M. to be continued at a later date.

Mayor Browns reopened the meeting with Councilmen Erickson, DuBois, Getz, Bourne, and Nash.

Treasurer Vandersluys and Attorney Schmidt were present.

Ordinance #400, 1974 Budget was read. Discussion was had on the raise from \$12 to \$20 per month for councilmen.

Bourne and DuBois were opposed to the raise. Three Councilmen were in favor. Wages for Foreman and crew were set to equal San Juan County's wages for equal work; Foreman, \$4.43 per hour and crew, \$4.01 per hour. All other parts of the Budget Ordinance were approved. Ordinance \$4.01 fixing salaries on elected officials and Town employees was read and approved with the necessary changes to reflect the same wage changes for Foreman and crew as in the Budget Ordinance.

There being no further business the Council adjourned at 1:15 P.M.

Ordinance #400, the Budget Ordinance, Town of Friday Harbor budget for the year 1974 was given second reading. Motion was made by Bourne and seconded by Nash to adopt Ordinance #400 and was unanimously approved.

Ordinance #401, an ordinance of the Town of Friday Harbor fixing salaries of all elected officials and all town employees, was given second reading. A motion was made by Bourne and seconded by Nash to pass Ordinance #401 and was unanimously approved.

Discussion was had on the County's participation in our Refuse Site. It was decided that if we don't have any agreement or payment by the next council meeting the Refuse Site will be closed to the County.

Mayor Browne requested Attorney Schmidt to attend a meeting with the County Commissioners Dec. 21, 1973 to find out what they intended to do about the debt for the use of the Refuse Site for the past six months.

Mr. Royce Brill representing Mr. Charles Baer requested Use Water Rights for about 50 houses on the University Heights property at 800 gallons per day each or approximately 140,000 gallons per day. Mayor Browne's advised Mr. Brill to make a written application to the Council in accordance with the instructions in the Town's Water Extension Book.

Mayor Browne instructed Attorney Schmidt to look up the liability laws regarding the sidewalks especially Spring Property Inc.

Mayor Browne directed the Clerk to write a letter to County Commissioner Whitmill asking about our representation to the Water Pollution Abatement Coordinating Committee.

Mayor Browne directed the Clerk to write a letter to the Bureau of Land Management showing the Town Council's approval of the local Motorcycle Club.

Mayor Browne requested that the Town Clerk get a written agreement from Art Petrich on the bulldozer used at the Refuse Site.

Councilmen Getz was presented with a gift from the Council for his 10 years of faithful service to the Town. The gift consisted of a barometer, thermometer and hydrometer.
