Council met in regular session with Mayor Browne presiding.

Attorney Schmidt gave the oath of office to Mr. James E. Browne for Mayor and Mr. James Cahail for Councilmen.

Councilman present: Kenneth Nash, Howard DuBois, and James Cahail.

Others: Treasurer Vandersluys, Attorney Schmidt, Foreman Burton, and Marshall Gates.

Minutes of previous meeting were approved as read. Motion was made by DuBois, seconded by Nash to pay bills and was unanimously approved.

Correspondence:

Ed Bourne: resignation as Councilman

William Erickson: resignation as Councilman.

Charles Baer: Application for interconnection to Developer's (University Heights) water system with Town's system.

San Juan County Commissioners: refuse agreement

Royce Brill: Turn Point Water Users Assoc. connection to the Town's water system.

Turn Point water line was discussed. The Turn Point Assoc. requested from the Council that they not be required to produce a performance bond for the new proposed Turn Point Water extension line. They were informed by Attorney Schmidt that when and if the extension is approved by the Town Council, Turn Point Water Assoc. would be responsible for the installation of the new lines, in accordance with the Town engineers specifications and with their approval. They would also be responsible for the future upkeep and liability of the line. The Turn Point Water Users Assoc. also requested from the Council that there be a pay back agreement for future water connections on their line. Whereby they could recover part of their initial investments. Mayor Browne directed the Clerk to inform Royce Brill that he should familiarize himself with the Town's Water Rules and Regulations Manual. Council tabled the Turn Point Water Assoc. request to wait approval of and consultation with the Town's engineers.

Mayor Browne appointed a committee consisting of Ed Bourne and Charles Schmidt to meet with the County Commissioners to finalize the refuse agreement between the Town and County.

Motion was made by DuBois, seconded by Nash to pass Resolution #269, A Resolution of the Town Council of the Town of Friday Harbor expressing the Appreciation of the Citizens of the Town of Friday Harbor, its Town Council and its Mayor for the Years of Loyal Service Rendered to it by Retiring Councilmen, Lawrence W. Getz and was unanimously approved.

The bid from Ohlson Tractor was opened and was in the amount of \$11937.12. The bid was referred to the Town's Foreman for approval.

Agreement for the dozer at the refuse site with Art Petrich was discussed. Mayor Browne requested Treasurer Vandersluys to discuss the financing of the bulldozer at the refuse site with Art Petrich pending the Councils approval.

Attorney Schmidt presented the Council with a plan for replat of Tracts C & D of Price's Harbor View Addition to a Private Subdivision and discussion followed. Attorney Schmidt also requested that the Town procure the services of a disinterested Attorney to council them on this matter. Warren Jones objected to the plan because it did not contain all the information that was requested in Ordinance #379. An Ordinance relating to subdivision and plats within the Town of Friday Harbor: and prescribing for penalties for violations thereof. Mayor Browne suggested a proper plat be submitted.

Joe Fanjul was present on behalf of the Chamber of Commerce to discuss parking lot behind the Town Hall, which they had agreed to finance. Discussion was had. The Council would rather not renegotiate the contract for the parking lot and requested the Chamber of Commerce to negotiate directly with Mr. Thomas Blunden.

Meeting was closed at 10:10 P.M. to be reopened on January 7, 1974.

Mayor Browne reconvened the Council meeting at 12 noon on January 7, 1974.
Councilmen present: Nash, DuBois, and Cahail.

Turn Point Water line was discussed. Mayor Browne turned over the Turn Point water line plans to Councilman James Cahail for his review. Turn Point Water Users Assoc. are to submit a set of plans to KCM for their approval as soon as Councilman Cahail has reviewed them.

Motion was made by DuBois, seconded by Nash to accept Resolution #290, A Resolution of the Town of Friday Harbor accepting the bid for a Tractor with Backhoe and Loader from Ohlson Tractor and Implement Co., Inc. and was unanimously approved.

Councilman Nash inquired about the poor condition of Blair Street. He was informed that until property owners pay for the original ballast and seal coats as has been done on all other streets in Friday Harbor the Council was unable to use public funds to repair the road.

There being no further business Council meetings adjourned at 1:20 P.M.

Mr. Sam Buck and his architect, Mr. Jerry Cichanski, presented drawings and a scale model of a proposed plan for rebuilding the Old Friday Harbor Cannery area. The plan consisted of apartments, motel, shops, restaurant, commercial area, floats, and parking. The architect explained that the highest point of the buildings will be 14 feet above Warbass Way. But this will not block any more view but by tearing down the old cannery it would even open up more of a view. The plan showed that a walk around most of the waterfront would be opened to the public. The structure will be built primarily of wood. Mr. Sam Buck introduced Mr. Talbot and Mr. Taylor who are part owners in this project. The two gentlemen explained to the Council how the cannery as it is at present is a hazard. Mayor Browne decided to reactivate the Shoreline Management Planning Committee to meet with Mr. Sam Buck and his architect, to discuss the plan. Sam Buck invited Mayor Browne and Council to attend the preliminary public meeting of the proposed plans of January 31, 1974.

Top of the Harbor preliminary plan was discussed. Councilman DuBois requested further information on the idea of a private road within the Town of Friday Harbor. Charlie Schmidt advised Council that a corporation would be established to maintain the private roads and that the Town would not be held liable. He also advised Council he would request a 5-year LID for water and sewer for about \$15,000.00, half of which he would advance in cash. The balance would be attached to the initial 7 lots. A motion was made by DuBois, seconded by Cahail to hold a public hearing on Feb. 7, 1974 for the preliminary plat of Top of the Harbor and was unanimously approved. A disinterested Attorney representing the Town will be present at that time.

A motion was made by DuBois, seconded, by Cahail to present a set of plans of the Top of the Harbor to the County and was unanimously approved.

Mayor Browne directed the Clerk to call KCM and ask Mr. Dick Warren to come to Friday Harbor to discuss with the Council the proposed University Heights and Turn Point water extensions.

Council discussed the filling of the empty Council positions.

Marshall Gates requested Ordinance #251 be revised to include class H licenses also permits for other dances.

Marshall Gates also requested revamping Ordinance #206. Mayor Browne appointed Treasurer Vandersluys and Marshall Gates to work out a permit price for pin ball machines.

Motion was made by DuBois, seconded by Nash to purchase dozer from Art Petrich at the negotiated price.

Mayor Browne gave Foreman Burton permission to install a 6-inch water line on Carter Street as long as the Opalco ditch is available.

Meeting was closed at 11:00 P.M. to reopen at 11:00 A.M. on Jan. 30, 1974.

Mayor Browne reconvened the Council meeting at 11:00 A.M. on January 30, 1974.

Councilmen present: Howard DuBois and James Cahail.

Others: Mr. Dick Warren and Mr. Dan McDonald the Town Engineers.

Mr. Alan Carter inquired about the status of LID #39. He was informed that the plans and specifications were here and bids would be called for at the next Council meeting.

The Town Officials and Engineers made an on site inspection of University Heights and Turn Point proposed water extension projects.

Mr. Schmidt, attorney for Turn Point Water System discussed a possible pay back agreement, whereby the original investors would get a portion of their investment back, by charging \$1500.00 for each new membership. Mr. Dick Warren suggested entering into such a contract with Turn Point Water Corporation. Discussion was had on the deeding of the Turn Point Water Line to the Town. Mayor Browne asked Dick Warren and Charlie Schmidt to work out a contract for the Turn Point Water Line. Mayor Browne asked Mr. Dick Warren to meet with Mr. Royce Brill, Turn Point Engineer, to be sure the Turn Point Water Line be brought up to Town's standards. Turn Point Water Assoc. was informed a performance deposit in accordance with the Town of Friday Harbor Water Extension Regulations would be required to cover our cost for engineer inspections of the installation balance to be refunded after the line is approved. Any take off from the main extension would have to be inspected and approved by the Town's engineers.

University Heights Water System was discussed with Mr. Royce Brill. Mr. Brill was informed that the University Heights water plans as presented were not acceptable. All extensions have to meet Town standards.

There being no further business the meeting was adjourned at 1:00 P.M.

Council met in regular session with Mayor Browne presiding.

Councilmen present: Cahail, DuBois, and Nash.

Others: Treasurer Vandersluys, Attorney Schmidt, Attorney Russell, Foreman Burton, Marshall Gates, and Fire Chief Leake.

Minutes of the previous meeting were read and approved after changes.

Motion was made by DuBois, seconded by Nash to pay bills and was unanimously approved.

Correspondence:

Floyd Meyers: request for water hook-up.

State of Washington: Census for 1974.

Amos Coffelt: sewer line for Paul Dossett.

Joan Lowe: bill for damages.

U.S. Dept. of Interior: Permission to perform tests in Trout Lake.

Mayor instructed the Clerk to inform Mr. Meyers he would need to obtain a letter from Mrs. Anna Kaseburg for permission to hook-up to the water line.

Mayor Browne appointed Ralph Rich to fill position #2 vacated by William Erickson. Attorney Schmidt gave the Oath of Office to Mr. Ralph Rich.

Mayor instructed the Clerk to send the bills from Joan Lowe and Ted Lawson to Wolfstone, Donley, & McMannama the Town's insurance brokers.

Discussion was had on L.I.D. #39. Amos Coffelt asked why a 6-inch line could not be used instead of an 8-inch line. He was informed that there were Health and Town standards that had to be met. Motion was made by DuBois, seconded by Cahail to call for bids for L.I.D. #39 and was unanimously approved.

Motion was made by Nash, seconded by DuBois to allow Mr. Timothy Anderson a temporary hook-up to the existing line at Harbor View and was unanimously approved.

Discussion was had on Charlie Schmidt's, private subdivisions Top of the Harbor. Warren Russell was present as Council for the Town. The proposed private roads were discussed. The Town will have an easement over the private roads for emergency use. The Town would not accept ownership of the roads in the future unless they are brought up to Town standards. Motion was made by Cahail, seconded by Nash to grant a variance from the Town Ordinance #379 to allow for a private road and was unanimously approved.

Motion was made by DuBois, seconded by Cahail to allow the developer, to provide a bond rather than the completion of the utilities before the sale according to R.C.W. Chapter 58, and was unanimously approved.

Motion was made by DuBois, seconded by Nash to accept all the portions of Tracts "A", "C" and "D" of Price's Harbor View Addition for annexation upon the presentation of the petition and was unanimously approved.

Motion was made by Cahail, seconded by Nash to accept the preliminary plat on the Top of the Harbor when the petition for annexation has been accepted, and was unanimously approved.

Mr. Sam Buck requested an impact statement from the Council on his project at the old cannery.

Mayor Browne designated the Town Clerk as the Town's official agent to accept all information and applications on the impact studies.

Mr. Charlie Nash presented Mr. John Thalacker and Mr. McAbee to the Council. They described the new Counties address system, and requested that the Town Council adopt a similar system, which they have been working on for the Town that would be more compatible with the Counties system than the Town's present system. Motion was made by DuBois, seconded by Cahail to adopt the proposed grid system and was unanimously approved.

Treasurer Vandersluys attempted to explain the fallacy of owning a water line out side of the Town when the same rights could be obtained by the Town not owning the line. Motion was made by Nash, seconded by DuBois to adopt Resolution #291, a resolution authorizing the Mayor to enter into a contract with Turn Point Water Users Assoc. upon receipt of the contract and specifications approved by KCM.

Motion was made by DuBois, seconded by Cahail to adopt Resolution #292, a resolution accepting the plans and specifications for extension to the Town of Friday Harbor's sewer system as presented by Paul Dossett, upon the written approval of KCM. Council gave Mr. Dossett a 6 month time limit to start the project.

1901 Corp. submitted a Shoreline Management Application to the Council with request for a negative impact statement.

Motion was made by Nash, seconded by DuBois to adopt Resolution #293, a resolution authorizing the Mayor to enter into a contract with Mr. Arthur Petrich for the purchase of his bulldozer and was unanimously approved.

Mayor Browne gave the Dept. of Interior permission to conduct a research project of Trout Lake.

Mayor Browne appointed Councilmen DuBois and Nash also Mr. Ed Bourne as a committee to meet with representatives of Fire District #3 during the Month of March.

Rough drafts of Ordinances on pinball machines and dance permits were distributed to the Council for their comments.

Council turned down the offer for the use of a piece of land behind the old moose hall for a parking lot as being not accessible.

Fire Chief Leake advised Council that the new fire truck is ready for delivery.

There being no further business Council adjourned at 11:45 P.M.

Motion was made by Dubois and seconded by Rich to publish a notice to set a March 21st as a date for a public hearing for annexation on Top of the Harbor, and was unanimously approved.

Mayor Browne instructed the Clerk to send the LID plans for Top of the Harbor to KCM.

Discussion was had on the beautification of the end of West Street. Councilman Rich met with Mr. Archie Erickson. Foreman Burton and Marshall Gates were asked to look over the site. Council had no objections to the beautification program, and it was noted that future councils might make alterations. A suggestion was made that a "no camping" sign be posted.

Council approved the installation of the new litter cans.

Mayor instructed Clerk to publish a notice of public meeting on March 21, for Shoreline Management Application for 1901 Corp.

Motion was made by Nash and seconded by Reed to add the streetlight in the Sunshine Alley by Friday Harbor Electric to the Town's street light bill, unanimously approved.

Discussion was had on fuel allocation for Marshall's deputies.

Unanimously approved.

Jim Semour from General Electric explained to the Council what was needed to update our radio system at a cost of \$285.00 plus installation. Council asked Mr.

Semour to prepare a letter on the cost of the new channel guards for them to consider. The Council agreed to update the equipment to pass FCC laws.

Robin Sanderlin asked the Council for their opinion on the proposed open-air market. The Council thought the idea was appealing.

Motion was made by Reed and seconded by Nash to adopt Ordinance #403 an ordinance annexing certain territory unto the Town of Friday Harbor and was unanimously approved.

Discussion was had on the Shoreline Substantial Development Permit for 1901 Corp. The parking problem was raised. Environmental consideration of 1901 Corp. was discussed. Motion was made by Rich, seconded by Nash to approve 1901 Corp. Application for Substantial Development, all the Councilmen present voted favorably except Councilman DuBois who abstained. The project would not have an impact so an environmental impact study is not required.

Motion was made by Reed, seconded by DuBois to accept the agreement with Fire District #3 with changes and was unanimously approved.

Discussion was had on Turn Point Water Line. A \$2000.00 deposit for inspection and bookkeeping was decided plus \$250.00 fee for hook-up.

Motion was made by Cahail, seconded by Rich to pay the bills and was unanimously approved.

Councilman Reed will inform the Chamber of Commerce about the letter from Mr. Thomas Blunden. Clerk to write to Mr. Blunden that the Town will not be leasing his property at \$600.00 a year for the parking lot.

Mayor Browne signed an agreement for fire protection for County Fire District #3.

Motion was made by Rich, seconded by DuBois to accept Mr. Sam Buck's offer to donate up to \$6000.00 towards the expense of acquiring information needed by the Town to compile the Cannery Village Impact Statement. Unanimously approved.

Motion was made by DuBois, seconded by Reed to consider the Cannery Village project a substantial development, therefore, proceed with the preparation of an environmental impact study and was unanimously approved.

Councilman DuBois agreed to attend the County Commissioners meeting Monday to discuss the refuse agreement.

Mayor Browne requested Mr. Vernon Leake to submit plans of his new home to the Council.

Motion was made by Reed, seconded by Cahail to adopt Resolution #296, a resolution authorizing the Mayor to enter into a contract with San Juan County for the joint use of the Town's refuse site for the benefit of both parties.

Mr. Wilmer representing Friday Harbor Stage Company was present to discuss the possible operation of a local public transportation system. Mr. Wilmer requested the Council to reserve two parking places in Town for bus parking only. Council decided to investigate the request further and discuss it at a future Council meeting.

Attorney Linde mentioned to the Council the parking problem at the ferry landing. Attorney Linde will write to the State Ferry System regarding the ferry traffic in Friday Harbor.

State wide fire and building code was discussed. Mayor Browne instructed the Clerk to write to the Professional Licensing Department requesting copies of these codes.

Mayor Browne appointed Mr. James Browne Jr. as the Towns representative to the County's committee on a community airport.

Motion was made by Cahail, seconded by Rich to adopt Resolution #297, authorizing the Mayor to enter into contract with San Juan County Road District for repairing and improving the Town's arterial and streets and was unanimously approved.

A resolution calling for bids for 30,000 gallons of emulsified road asphalt to be supplied on or about May 1, 1974. Bids to be opened at the Council meeting April 18th, and was unanimously approved.

Mr. William Erickson representing Friday Harbor Electric requested that the Town of Friday Harbor guarantee ownership to Friday Harbor Electric of their frontage on Sunshine Alley, which might be incidentally used by the public.

Council was recessed at 10:30 P.M. to be continued at 1:00 P.M. on Saturday April 6, 1974.

Council was reconvened on April 6, 1974 at 1:00 P.M. with Mayor Browne presiding.

All Councilmen, Treasurer Vandersluys & Attorney Schmidt were present.

Discussion continued on the impact statement on the Cannery Village. Attorney Schmidt representing Schmidt & Linde, in appealing for the job of writing the environmental impact statement for the Town of Friday Harbor on the Cannery Village project, stated the San Juan Properties had no financial interest in Schmidt & Linde, Attorneys-at-Law, nor had they any financial interest in San Juan Properties or the Cannery Village Project.

After do discussion motion was made by Nash, seconded by Reed to accept Schmidt & Linde's offer to do the environmental impact study which they estimated to cost around \$3500. All councilmen voted favorable except Rich who was opposed.

Mayor requested the Clerk to write for several copies of "Guidelines for Implementation of the State Environmental Policy Act of 1971" plus any revisions.

There being no further business Council adjourned at 1:50 P.M.

A letter from Union Oil of California, which was believed to be a bid on asphalt was opened, which stated they did not care to bid on the asphalt at this time. No other bids were received.

It was decided the Town could not afford to loose a parking space to be used by Friday Harbor Stage Company. Further study will be made on a suitable location.

Attorney Linde reported to the Council on his meeting with a representative of the State Ferries Commission on the ferry problems. Mayor Browne instructed the street and alleys committee to meet with Attorney Linde to discuss the problems and bring their findings to the Council and Ferry Commission.

Mr. Lloyd presented plans of his proposed apartments to be built on First Street to the Council. The Council decided this project would have such an insignificant impact on the environment that an environmental survey would not be necessary. The Council approved Mr. Lloyd's plans.

The Council was in favor and gave the go ahead on the beautification program for the end of West Street by the Grange.

Vernon Leake presented plans for his modular home and the Council approved them.

Mr. Joe Fanjul requested water from the Town of Friday Harbor for his property out side of the Town on Argyle Ave. Council advised Mr. Fanjul he should present plans, which were approved by KCM the Towns engineers to the Council.

Mayor Browne appointed a committee of Reed and Nash to look into our insurance coverage.

Council accepted the Cannery Village agreement to donate up to \$6000. to cover the cost of gathering information on an environmental impact study.

Motion was made by Reed, seconded by Cahail to adopt Resolution #299 a resolution of the Town of Friday Harbor authorizing the Mayor to enter into an agreement and license with Friday Harbor Plumbing & Electric.

The Clerk presented a report on the comparison between budgeted funds and expenditures for the first quarter of 1974, to the Council.

The Clerk was instructed to issue building permits for single family residence only and to refer all substantial development permits to the Council for approval.

Mayor Browne instructed the Clerk to publish a notice in the Journal that input statements for the environmental impact study of the Cannery Village project will be accepted at the Town Clerk's Office.

There being no further business Council adjourned at 9:30 P.M.

Councilman DuBois reported that he has talked with Mr. Sam Pope regarding his application for water hook-up to his single family residence described as a portion of the Northeast quarter of the Northeast quarter of Section 16, Township 35 North Range 3 West W.M. Motion was made by Nash and seconded by Cahail to grant permission for a water hook-up for a single-family residence on the above location for Mr. Sam Pope and was unanimously approved.

Mr. Robert Gregory and Mr. William Brant were present to present to the Council plans for a new bank building on Second Street. Motion was made by DuBois and seconded by Reed to make a negative declaration. Based upon a determination that the proposed action is not a major action significantly effecting the quality of the environment and was unanimously approved. The Mayor instructed the Clerk to issue the building permit, when the plans were completed and presented to her office.

Minutes of the previous meeting were approved as read. Motion was made by Cahail, seconded by DuBois to pay the bills and was unanimously approved.

A public hearing was held on the annexation of property on the northern limits of the Town, adjacent and part of Town & Country Trailer Court, owned by Mr. Don Crouch, description given in Ordinance #407. Motion was made by Reed, seconded by DuBois to adopt Ordinance #407 an ordinance annexing certain territory unto the Town of Friday Harbor and was unanimously approved. Treasurer Vandersluys introduced Ordinance #406, an Ordinance fixing the tax levy for the year 1975 and making such levy in the amount of \$29,417.92. Motion was made by Cahail, seconded by Nash to adopt Ordinance #406 and was unanimously approved.

Councilman Nash requested that the Council consider the possibility of a community swimming pool.

Council recessed at 9:15 P.M. to reconvene on October 7, 1974 at 10:00 A.M. in the Town Hall.

Council reconvened at 10:00 A.M. with Mayor Browne presiding.

Councilman present: Cahail, Bourne, Nash, & Reed.

Others: Treasurer Vandersluys.

Mr. Don Strong, District Engineer for the Department of Social and Health Services and Mr. Bolt also from Social and Health Services were present to answer questions by the Town Council pertaining to possible grant money for future work on the Town water supply and the purchase of water shed property. 3) There are 746 possible building sites remaining within the Town limits at the present time not including the Cannery Village.

Recommendations:

- 1) Install pumping stations for higher elevations in Town.
- 2) Reading residential meters in Town during the summer and charging for monthly overages based on annual rate.
- 3) Additional storage reserve for peak usage.
- 4) Allow only single family residential connections to the main line coming from the lake and then only within approximately 300 feet of the main line.
- 5) Establish a zone around the Town out side of which no new connections would be permitted.
- 6) Monthly water rent to continue throughout the year whether in use or not.
- 7) Higher overage rates for the University of Wash. and Friday Harbor Sand & Gravel.
- 8) Large users be permitted to draw only during periods of low usage and provide their own storage tanks.

Council adjourned at 1:25 P.M.

Charles Schmidt presented his final plans, approved by KCM for water & sewer construction, for Top of the Harbor development. Highway Commission: Environmental Impact Statements or Negative Declarations on all Federal-aid Highway Projects.

Motion was made by Reed, seconded by Nash to issue Mr. James Dogan a building permit to finish the remodeling of his apartments on "A" Street and was unanimously approved.

Jim Cahail representing Opalco informed the Council that they were planning to install 250 feet of underground line on Larson Street and that the Town's water line could be installed in the same ditch while it was open. The Council agreed to the installation of 250 feet of 6-inch water line that the Town has in stock. The Mayor instructed Foreman Burton to proceed with the installation and to cap the pipe for future use.

A petition, by the property owners of Price's Harbor View Addition, on the poor condition of Harbor View Place, torn up by LID #39 construction, was read. The Mayor instructed Foreman Burton to repair that portion of the road that was within the Town limits.

Dan McDonald was present to discuss the final assessment roll on LID #39. Motion was made by Cahail, seconded by Bourne to accept the assessment roll for LID #39 Harbor View, and was unanimously approved.

The Mayor instructed the Treasurer to publish the assessment roll and a notice that it was due and payable in accordance with the law.

Mr. Jim Capron was present to request an additional street light on Warbass Way between the first and second lights coming into Town from State Road. The Mayor instructed the Street Committee to inspect the site. Jim Capron also inquired about the possibility of hooking-up to the Town's sewer system.

Mayor instructed the Clerk to write a letter to the bereave widow of Capt. Spike Ekium expressing the sympathy of the Town Council.

Mr. Bert Lawson was present to request a water extension from the main line about one (1) mile out of Town. Mayor Browne informed Mr. Lawson that the Council would review his plans at a later date.

An Ordinance to adopt the State Building Code was introduced, discussed, and given first reading.

The Mayor instructed Foreman Burton to erect a Christmas tree on the corner of Argyle Ave. and Spring Street.

Treasurer Vandersluys discussed the 1975 budget with the Council. Mayor Dan McDonald informed the Council that the application for grant money on the Water

Filter Plant Reconstruction was accepted by the Department of Social and Health Services. He also informed the Council that the Town has a good chance of receiving grant money for step one of the Secondary Sewer System under referendum #26.

Dan McDonald informed the Council that a Settling Basin for the Water Filter Plant was not an expensive operation and could be built by the Town's crew also the law would not force us to complete one before 1977 and by that time there would probably be new grant money available.

There being no further business Council adjourned at 12:02 A.M.

Warren Russell representing Friday Harbor Sand & Gravel was present to inquire about the raising of water rates for Friday Harbor Sand & Gravel and was advised by the Council that the Ordinance would go into effect the beginning of January 1975. Mr. Russell also inquired about the request for approximately Five Million gallons of water a month by Friday Harbor Sand & Gravel. Mr. Russell was advised to communicate with KCM on its feasibility.

Motion was made by Reed, seconded by Nash to adopt Ordinance #408, an ordinance providing for the adoption administration and enforcement of the state building code and repealing all ordinances of the Town in conflict and was unanimously approved.

Motion was made by Bourne, seconded by Cahail to adopt Resolution #304, a resolution concerning future negotiations respecting off-street parking at the

Cannery Village site following the Washington State Ferries Survey and was unanimously approved.

The wage scale for 1975 was further discussed. Motion was made by Bourne, seconded by Cahail to adopt Ordinance #410, an ordinance fixing salaries of all elected and appointed officials and all Town employees. All Councilmen present voted in favor of this motion except Councilman Nash who expressed his feelings that the raises should have been larger.

All Councilmen present were in favor of reopening the labor agreement the middle of the year.

Motion was made by Nash, seconded by Cahail to adopt Ordinance #409, an ordinance authorizing the budgeting and expending in 1975 certain funds on hand and monies to be collected during 1975 and was unanimously approved.

Motion was made by DuBois, seconded by Bourne to adopt Ordinance #411, an ordinance to amend, revise, and further equalize water rates and was unanimously approved.

There being no further business Council adjourned at 11:10 P.M.
