Purpose

The purpose of this budget work session is for the first reading of the 2026 Utility Rates and Connection Fees. A discussion concerning the proposed rates will occur as outlined below on December 4, 2025 to take effect January 1, 2025. Direction by Council to staff will be needed at the end of the discussion for Council approval of provided ordinances. This will affect the following Friday Harbor Municipal Code (FHMC) Sections:

- 13.05 – Water Rates and Charges
- 13.21 – Sewer Rates and Charges
- 13.28 – Garbage Collection and Disposal
- 13.31 – Stormwater Rates and Charges

Rate Setting Policy

Base charges, use charges, connection charges, installation charges, and inspection charges shall be adjusted by either of the following conditions:

- Each January 1st by the percentage increase of the Seattle-Tacoma-Bellevue Consumer Price Index (CPI-U) as reported for the previous June to June period.
- Town Council action taken after review of the current adopted rate study.

Prior to increasing charges, all proposed increases are discussed with the council, typically during the budget season or upon adoption of a new rate study. Pursuant to applicable RCWs, rate increases notification for water, sewer, and stormwater charges do not require advanced notice while refuse charges require at least 45 days' notice.

Pursuant to RCW 35.67.020, cities and towns have the authority to construct, operate, and maintain systems with provisions for rate setting. Rates must be uniform for the same class of customers and consider factors such as location, cost of service, and conservation goals.

Consumer Price Index (CPI-U)

According to the US Bureau of Labor Statistics, the Seattle-Tacoma-Bellevue (previously Seattle-Bremerton) consumer price index for all urban consumers for the June-to-June period of 2025 was 3.8. The information below can be located on their website at:

Proposed Utility Rate Increases

Utility rates are imposed to fund the operational costs of a utility service. Rate increases are necessary for inflation and long-term capital needs. Proposed utility rate increases are for water, sewer, refuse, and stormwater services.

Water Rates

The Town provides water service for customers within the Town of Friday Harbor and a limited number of out-of-town customers. These customers are charged a monthly base fee and consumption charges. The out-of-town customers base fee is charged 150% above the in-town customers' base as established in rate studies. The differentiation did not apply to consumption charges. For 2025 rates, the 150% differentiation was also applied to the consumption charges for the out-of-town customers. For 2026, it is recommended to revert to having the same consumption charge rates for in-town customers and out-of-town customers until a new rate study can be completed.

In addition to water connections, bulk water sales are available for approved use within the Town limits or emergency situations approved by Town Council through the water pumphouse and temporary connections.

Water rates need to be increased to sustain increasing operating expenses and to support future projects. Currently, the Town is working on a 4th filter improvement project at the water treatment plant to significantly improve the plant's operational efficiency and ability to meet water treatment demands. In addition, capital reserves need to be built up to plan for other improvements throughout the water system, emergency repairs, and the future of the water treatment plant.

Rate increase options are based on the 2024 rate study or CPI-U as directed by Town Council.

- Rate Study Option: A 13% rate increase for water is recommended based on the current Utility Rate Study adopted on June 6, 2024, by Resolution No. 2855 and developed by Financial Consulting Solutions Group Inc (FCS Group).
 - Note: Future rate increases, based on the current rate study, as recommended are 7.5% per year going forward from 2027-2030.
- CPI-U Option: A 2.7% rate increase for water services is based on the Seattle-Tacoma-Bellevue CPI-U for the 2025 June-June period.

Bulk water sales by tank load or hydrant connection will be charged a base fee at 125% of the single-family residence in-town rate as described:

- Water sales by tank load through the Town's pumphouse will be charged this fee per hookup.
- Water sales by hydrant will be charged this fee per month.

Bulk water sales through temporary water connections that are utilized for construction purposes, not to exceed 1 year, will be charged as described:

- Water sales by temporary connection will be charged a monthly base fee at 125% of the rate listed above based on meter size, location, and zoning type.

Bulk water sales will be charged consumption charges as described:

- Water sales by tank load or hydrant usage will be charged at the single-family residence block 6 rate per 1,000 gallons.
- Temporary water connections utilized for construction purposes, not to exceed 1 year, will be charged monthly at the rate listed above for the seasonal rates.

Sewer Rates

Sewer rates need to be increased to sustain increasing operating expenses and to support future projects. Currently, the Town is working on a major rebuild of the existing wastewater treatment plant. While the Town was able to secure \$9,240,450 in funding for this project, the Town is required to make a match of \$1,060,070 for the project and cover any additional expenses outside of the project scope. In addition, capital reserves need to be built up to plan other improvements throughout the sewer system and for any emergency repairs.

- Rate Study Option: A 3% rate increase for sewer services is recommended based on the current Utility Rate Study adopted on June 6, 2024, by Resolution No. 2855 and developed by Financial Consulting Solutions Group Inc (FCS Group).
 - Note: Future rate increases, based on the current rate study, as recommended are 3% per year going forward from 2027-2030.
- CPI-U Option: A 2.7% rate increase for sewer services is based on the Seattle-Tacoma-Bellevue CPI-U for the 2025 June-June period.

Refuse Rates

Friday Harbor Municipal Code Section 13.28.150(E) states “The refuse service charge shall be increased or decreased so as to derive the required revenue to accomplish the tasks as outlined in the refuse budget as adopted by the town council”.

In partnership with San Juan County and the Solid Waste Capital Improvement Plan, there are potential expenses that could be coming for improvements to the refuse property and the adjoining San Juan County owned property. For planning purposes, it is recommended for a rate increase to follow the CPI-U as a recommended option with the other utility services provided by the Town.

- Rate Study Option: There is no rate study for recommendation.
- CPI-U: A 2.7% rate increase for refuse services is based on the Seattle-Tacoma-Bellevue CPI-U for the 2025 June-June period.

Stormwater Rates

Stormwater rates need to be increased to recoup lost revenue from increases not being followed based on the previous rate study, sustain increasing operating expenses, and build up capital reserves to plan for improvements throughout the stormwater system.

- **Rate Study Option:** The most recent rate study containing increases for stormwater services was the 2008 Utility Rate Study adopted on August 21, 2008, by Ordinance No. 1667, developed by Financial Consulting Solutions Group Inc (FCS Group). The recommendations for years 2008-2015 were not followed, nor increases from 2016-2024, and resulted in an approximate revenue loss of \$349,152. The 2025 rate increase of 25% or \$3.60 per ERU concluded that it would take 2.48 years to recoup those costs. This increase resulted in an additional \$153,185.02 revenue for September year to date, compared to September 2024 year to date.
- **Based on 2025 Discussion:** A 25% rate increase for stormwater services is recommended.
- **CPI-U Option:** A 2.7% rate increase for stormwater services is based on the Seattle-Tacoma-Bellevue CPI-U for the 2025 June-June period.

Proposed Utility Connection and Installation Increases

Utility connection fees are imposed as a condition of connecting to the utility system as a means of ensuring new customers bear their equitable share of the costs of a utility service. Connection fees are defined by a General Facilities Charge (GFC), which recovers existing costs, and a System Development Charge (SDC), which cover future costs.

Utility installation fees are a reimbursement cost determined by the Town for expenses incurred to connect a customer to the utility system. This fee is compiled of operational expenses related to connecting a new service.

Rate increases in connections are necessary to fund capital projects or pay debt services incurred to finance capital projects. Proposed increases to utility connections are for water, sewer, and stormwater services.

Water System Connection and Installation

Water rates need to be increased to support current and future projects. Currently, the Town is working on a 4th filter improvement project at the water treatment plant to significantly improve the plant's operational efficiency and ability to meet water treatment demands. In addition, capital reserves need to be built up to plan for other improvements throughout the water system, emergency repairs, and the future of the water treatment plant.

- Rate Study Option: A 13% rate increase for water is recommended based on the current Utility Rate Study adopted on June 6, 2024, by Resolution No. 2855 and developed by Financial Consulting Solutions Group Inc (FCS Group).
 - Note: Future rate increases as recommended are 7.5% per year going forward from 2027-2030.
- CPI-U Option: A 2.7% rate increase for water services is based on the Seattle-Tacoma-Bellevue CPI-U for the 2025 June-June period.

Sewer System Connection and Inspection Increases

Sewer rates need to support future projects. Currently, the Town is working on a major rebuild of the existing wastewater treatment plant. While the Town was able to secure \$9,240,450 in funding for this project, the Town is required to make a match of \$1,060,070 for the project and cover any additional expenses outside of the project scope. In addition, capital reserves need to be built up to plan other improvements throughout the sewer system and for any emergency repairs.

- Rate Study Option: A 3% rate increase for sewer services is recommended based on the current Utility Rate Study adopted on June 6, 2024, by Resolution No. 2855 and developed by Financial Consulting Solutions Group Inc (FCS Group).
 - Note: Future rate increases as recommended are 3% per year going forward from 2027-2030.
- CPI-U Option: A 2.7% rate increase for sewer services is based on the Seattle-Tacoma-Bellevue CPI-U for the 2025 June-June period.

Stormwater System Connection and Installation Increases

Stormwater rates need to be increased to recoup lost revenue from increases not being followed based on the previous rate study and build up capital reserves to plan for improvements throughout the stormwater system.

- **Rate Study Option:** The most recent rate study containing increases for stormwater services was the 2008 Utility Rate Study adopted on August 21, 2008, by Ordinance No. 1667, developed by Financial Consulting Solutions Group Inc (FCS Group). The recommendations for years 2008-2015 were not followed, nor increases from 2016-2024, and resulted in an approximate revenue loss of \$349,152. The 2025 rate increase of 25% or \$3.60 per ERU concluded that it would take 2.48 years to recoup those costs. This increase resulted in an additional \$153,185.02 revenue for September year to date, compared to September 2024 year to date.
- **Based on 2025 Discussion:** A 25% rate increase for stormwater services is recommended.
- **CPI-U Option:** A 2.7% rate increase for stormwater services is based on the Seattle-Tacoma-Bellevue CPI-U for the 2025 June-June period.
