

RESOLUTION NO.2338

A RESOLUTION by the Council of the Town of Friday Harbor confirming the 2018 wage schedule for represented personnel.

WHEREAS, the Town of Friday Harbor adopted a Collective Bargaining Agreement for years 2016 through 2018 with the Washington State Council of County and City Employees, AFSCME, AFL-CIO, Local 1849F (the Union); and

WHEREAS, the adopted Collective Bargaining Agreement prescribes a cost of living adjustment in the year 2018 of an amount equal to 100% of the increase reported by the Seattle-Tacoma-Bremerton Consumer Price Index for all Urban Consumers (Seattle CPI-U) for the preceding June to June period, PROVIDED THAT the adjustment will be a minimum of 1.5% and maximum of 3.5%; and


WHEREAS, the Seattle CPI-U reports a market adjustment of 3.0% for June 2016 to June 2017; and

WHEREAS, the Town of Friday Harbor desires to confirm the wage schedule for represented personnel for year 2018; and

NOW, THEREFORE, the Town Council of Friday Harbor does hereby resolve that the wage schedule attached hereto as Exhibit A shall be in effect January 1, 2018 through December 31, 2018.


